- 1. 바울 신학의 역사적 발전(Historical Development of Pauline Theology)
  - 1) 초대교회 시대의 바울 신학 수용

Reception of Pauline Theology in the Early Church

- (1) 바울의 서신들은 초기 교회 공동체 안에서 권위 있는 문서로 받아들여 졌으며, 교리 형성과 윤리 교육의 기초가 되었음
  Paul's epistles were received as authoritative documents within the early Christian communities and became foundational for doctrine and ethical instruction.
- (2) 베드로 후서(3:15-16)에서도 바울의 서신을 '성경'으로 간주함 2 Peter 3:15-16 treats Paul's letters as Scripture.

## Ⅱ. 교부 시대의 해석

Interpretation in the Patristic Period

- 1) 오리겐, 어거스틴 등의 교부들이 바울 신학을 주석하고 조직화함 Church Fathers such as Origen and Augustine commented on and systematized Pauline theology.
- 2) 어거스틴은 바울의 "은혜" 사상을 통해 원죄와 예정론의 기초를 세움 Augustine developed the doctrines of original sin and predestination through Paul's theology of grace.

## Ⅲ. 중세 스콜라주의와 바울 해석

Medieval Scholasticism and Pauline Interpretation

- 1) 중세 신학자들은 바울의 율법, 은혜, 믿음의 관계를 교리적으로 재정립함 Medieval theologians redefined the relationship between law, grace, and faith in Pauline thought.
- 2) 그러나 성경 본문보다는 교회 전통과 철학적 사유가 중심이 되었음 Yet their interpretations were often shaped more by church tradition and philosophical reasoning than the biblical text itself.

The Reformation and the Recovery of Pauline Theology

1) 마르틴 루터는 바울의 "이신칭의" 교리를 통해 로마 가톨릭의 공로주의를 비판함

Martin Luther emphasized "justification by faith" from Paul to critique the merit-based system of Roman Catholicism.

- 2) 갈라디아서, 로마서를 중심으로 바울의 복음이 재조명됨
  Paul's gospel was reilluminated through Galatians and Romans.
- 3) 칼뱅은 바울을 중심으로 조직신학을 재구성함
  John Calvin restructured systematic theology centered on Paul.

1) 신정통주의 (Neo-Orthodoxy):

칼 바르트는 바울의 "하나님의 주권"을 강조

Karl Barth emphasized God's sovereignty in Pauline theology.

E.P.샌더스,제임스 던, N.T. 라이트 등은 유대교적 배경에서 바울을 재해석 E.P. Sanders, James D.G. Dunn, and N.T. Wright reinterpret Paul within his Jewish context.

3) 바울을 통한 사회 윤리적 해석:

해방신학, 페미니즘 신학 등 다양한 시각에서 바울의 공동체 사상을 분석 Liberation theology, feminist theology, and others explore Pauline community ethics and justice.
